The bids will be opened in the presence of Bidders' representatives who choose to attend at 2022/03/30 13:00 PM at the office of Gautam Buddha International Airport Aero Synoptic Station, Bhairahawa, Rupandehi. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs 45000 which shall be valid for 30 days beyond the validity period of the bid (i.e.[Refer Clause ITB 20.1]).
