- Bidding documents may be purchased from the office by eligible Bidders on the submission of a written application accompanied by a letter of Authority from the firm to the address above along with the copy of Company/Firm registration certificate. The payment mode may be direct deposit or bank transfer to the **Gov. Revenue A/c Title No.14227 on Rastriya Banijya Bank, Thamel, Kathmandu, Nepal or Bankers cheque payable to Department of Hydrology and Meteorology, Kathmandu, Nepal.
