- 6. Electronic bids must be submitted online through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 14:00 noon on 2081-10-10
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at *12:10pm on* 2081-10-10 at the 3rd floor of DHM office, Babarmahal, Kathmandu.
- 8. Bids must be valid for a period of *90 days* from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. NPR 1,50,000.00, *which* shall be valid for 30 days beyond the validity period of the bid.
