If so requested, the Bidding Documents can also be sent by courier services/mail upon payment of additional cost of NRs. 10,000.00 (Ten Thousand Nepalese Rupees). However, the Purchaser will not be responsible for delay or non-delivery of the documents so sent whatsoever the cause thereof.
- Sealed bids must be submitted to the Procurement Unit of Department of Hydrology and Meteorology. Documents received after submission deadline shall not be accepted.
- Bids shall be opened in the presence of Bidder's representatives who choose to attend on the opening date given in above Table **at the office of Department of Hydrology and Meteorology, P.O.Box 406, Nagpokhari, Naxal, Kathmandu, Nepal.** Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amount given in above table, which shall be valid for minimum 30 days beyond the bid validity period (i.e. Total 120 days from the day of bid opening).
- If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
